

As one of the leading research universities in Germany, the Ruhr University Bochum is a reform-oriented campus university that features the entire range of major scientific fields in one place in a unique way. The dynamic coexistence of subjects and subject cultures offers researchers and students alike special opportunities for interdisciplinary cooperation.

The Ruhr University Bochum Hospital (UK RUB) is made up of qualified hospitals and specialised medical facilities in the Bochum, Herne and East Westphalia-Lippe region that cooperate with the Ruhr University. The UK-RUB stands for patient care at the highest level and excellent research and teaching in university medicine. The formation of so-called translational nuclei is intended to firmly anchor translational research in the research profile of the Medical Faculty of Bochum.

At the LWL University Hospital Bochum, the Clinic for Psychosomatic Medicine and Psychotherapy has a vacancy for the position of a

The clinic has 44 (partially) inpatient treatment places, a large outpatient clinic as well as consultation and liaison services. The previous treatment and research focus is particularly on eating disorders, trauma sequelae, psychosomatic and somatopsychic disorders and non-substance-related addiction disorders.

The clinic cooperates with numerous university clinics and hospitals in the cities in the Ruhr region.

The clinic's research is well equipped in terms of staff and space and includes both basic (imaging) and health care research as well as a W2 professorship for pain research. Within the framework of the integrated reform degree programme, teaching includes lectures, seminars and practical courses in addition to partial interdisciplinary lectures.

We are looking for a doctor of psychosomatic medicine and psychotherapy with several years of experience in leading management positions who can competently represent the entire specialist field of psychosomatic medicine and psychotherapy at the UK-RUB. The candidate should have a proven research profile in interdisciplinary and translational research. Competences in teaching and a strong commitment to the promotion of young researchers are required.

The candidate is expected to integrate into the research priorities of the faculty (oncology, neurosciences and protein sciences). Clinical-scientific collaborations with institutions of the

Faculty of Medicine and the UK RUB in the existing research priorities and development areas as well as participation in existing and future collaborative research projects are desired.

Applicants must have a positively evaluated junior professorship, habilitation or, alternatively, equivalent scientific achievements as well as a specialist qualification in psychosomatic medicine and psychotherapy. In addition to outstanding scientific qualifications, successful acquisition of third-party funding and willingness to participate in academic self-administration are also required:

- a pedagogical aptitude and a high level of commitment to teaching
- the willingness to engage in interdisciplinary scientific work
- the willingness and proven ability to acquire significant externally funded research projects.

The appointment procedure is carried out by the Ruhr University Bochum in agreement with the Landschaftsverband Westfalen-Lippe (LWL). The appointment is made on the basis of a service contract under private law. The connection to the university shall be in accordance with § 9 (2) HG NRW.

RUB and LWL stand for diversity and equal opportunities. Therefore, we promote the cooperation of heterogeneous teams and the career path of people who are underrepresented in the respective fields of work. The RUB explicitly wishes women to apply. In areas where they are underrepresented, they are given preferential consideration if they have the same qualifications. Applications from people with disabilities are most welcome.
